A high performance concrete superplasticiser, based on polycarboxylic technology

Uses

Structuro 201 is a high performance superplasticiser intended for applications where increased early and ultimate compressive strengths are required, and it has been developed for use in:

- Precast applications
- Concrete requiring long workability retention
- High performance concrete

Advantages

- Excellent water reduction ability
- Increased early and ultimate compressive strengths
- Increased flexural strength
- Higher E modulus
- Improved adhesion to reinforcing and stressing steel
- Better resistance to carbonation
- Lower permeability

Description

Structuro 201 is differentiated from conventional superplasticisers in that it is based on a unique carboxylic ether polymer with long lateral chains. This greatly improves cement dispersion. At the start of the mixing process an electrostatic dispersion occurs but the cement particle's capacity to separate and disperse. This mechanism considerably reduces the water demand in flowable concrete.

Structuro 201 combines the properties of water reduction and workability retention. It allows the production of high performance concrete and/or concrete with high workability.

Structuro 201 is a particularly strong superplasticiser allowing production of consistent concrete properties around the required dosage.

pH	: 6.5
Volumetric mass @ 20°C	: 1.09 kg/litre
Chloride content	: < 0.1%
Alkali content	: Typically less than 1.5 g Na ₂ O equivalent / litre of admixture.

Dosage

The optimum dosage of Structuro 201 to meet specific requirements should always be determined by trials using the materials and conditions that will be experienced in use. The normal dosage range is between 0.5 to 3.0 liters/100 kg of cementitious material.

Use at other dosages

Dosage outside the normal range quoted above can be used to meet particular mix requirements. Contact Fosroc for advice in these cases

Overdosage may cause delay in the setting time.

Structuro 201 is available in 200 litre drums.

Storage

Structuro 201 has a minimum shelf life of 24 months provided the temperature is kept within the range of 2°C to 50°C. Should the temperature of the product fall outside this range then contact local Fosroc office for advice.

Precautions

Health and safety instructions
